No return trips to the property are included. Additional charges will apply for return trips. Client agrees to read the following agreement carefully. Client understands that Client is bound by all the terms of this contract.

NON-EXCLUSIVE LICENSE AGREEMENT: Client understands and agrees that this agreement if for a non-exclusive license valid for SIX (6) MONTHS from the date of photography. The non-exclusive license is for the client to use the photos/videos/3D Virtual Tour in whatever manner they choose, including but not limited to market of a home for sale, archtectural use, showing leased/rental properties, pre- or post-occupancy documentation, insurance claims, auction, etc.

EXTENDED HOSTING: Client may extend their license in SIX (6) MONTH Increments for \$95.

SCOPE OF SERVICE: Client grants permission to Company to capture photographs and videos to create a 3D Virtual Tour model of the above-referenced property. Permission includes the right to bring personnel and equipment onto the property and to remove them after completion of the work. DELIVERABLE: Company will provide client a link which can be used to embed the 3D Virtual Model into a website. This HTML code is provided without technical support or web design services. Company is not a web design company and does not offer these services. Basic instructions on embedding the code will be provided. The 3D Virtual Model will reside on servers owned and operated by Matterport.

Client hereby gives to Company the right and permission to copyright, use, exhibit, display, print, reproduce, televise, broadcast and distribute, for any lawful purpose, in whole or in part, through any means without limitation, any scenes containing the above described premises, all without inspection or further consent or approval by the undersigned of the finished product or of the use to which it may be applied, in perpetuity without compensation.

PREPARATION: Client agrees to have the property ready on the day of, and at the time of the appointment. Company is not a cleaning service and does not return to re-shoot any area that is not prepped and ready. Therefore it is important for Client to:

- Clean the house. The camera is high resolution and will reveal clutter and unclean areas.
